

1 **OVERTURE 20** from Pacific Northwest Presbytery (to CCB, OC)  
2 "Amend *BCO* 31-10 and 33-4 on Pre-trial Non-Disciplinary Suspensions"  
3

4 **Be it resolved** that *BCO* 31-10 and *BCO* 33-4 be amended by addition, as follows (underlining  
5 for additional wording):  
6

7 ***BCO 31-10.*** When a member of a church court is under process, all his official  
8 functions may be suspended at the court's discretion; but this shall never be  
9 done in the way of censure, and this requires a three-fourths (3/4) majority.

10  
11 ***BCO 33-4.*** When it is impracticable immediately to commence process against  
12 an accused church member, the Session may, if it thinks the edification of the  
13 Church requires it, prevent the accused from approaching the Lord's Table until  
14 the charges against him can be examined, but this requires a three-fourths (3/4)  
15 majority.  
16

17 **Rationale:**

- 18 1. Indictment only requires a simple majority, but the bar should be higher for a court to  
19 "administratively" suspend someone from office or from the Lord's Table *prior* to the  
20 accused even presenting a defense. Granted, the court should retain this option when it is  
21 clearly warranted, but when it is warranted it should be clear to a three-fourths majority.  
22 To help ensure that a non-disciplinary suspension from office is "*never* done in the way  
23 of censure," it should require a three-fourths (3/4) majority.  
24
- 25 2. This is particularly important because the *BCO* does not stipulate a deadline for the court  
26 to conduct the trial.  
27
- 28 3. Furthermore, because it is not possible for a higher/appellate court to promptly review  
29 whether such a non-censure suspension is actually "not done in the way of censure," or  
30 whether "the edification of the Church requires it," the 3/4 majority will help ensure that  
31 a non-disciplinary suspension is clearly warranted.  
32
- 33 4. Ministers – While a Presbytery cannot impose a pre-trial suspension from office "in the  
34 way of censure," it would certainly *feel* like a censure to a defendant who is a minister,  
35 and likely have a similar effect. And unless his church can afford to pay him *and* his  
36 temporary replacement, the non-disciplinary suspension would almost certainly impact  
37 his salary and his family's finances (unlike church members or elders under similar non-  
38 disciplinary suspensions).

- 40 5. Below are a few other things for which the *BCO* requires a three-fourths (3/4) Presbytery  
41 majority. A pre-trial suspension should also be placed in this super-majority category.

43 19-16. Where circumstances warrant, a Presbytery may approve previous  
44 experience which is equivalent to internship. This equivalency shall be

1           decided by a three-fourths (3/4) vote of Presbytery at any of its regular  
2           meetings.

3           21-4. No Presbytery shall omit any of these parts of trial for ordination except  
4           in extraordinary cases, and then only with three-fourths (3/4) approval  
5           of Presbytery.

6           21-4.a. No Presbytery shall omit any of these [ordination] educational  
7           requirements except in extraordinary cases, and then only with a three-  
8           fourths (3/4) approval of the Presbytery.

9           21-4.c. [An ordination candidate] shall further be required to preach a sermon  
10          before the Presbytery or committee thereof, upon three-fourths (3/4)  
11          vote.

12          34-8. ...The removal of deposition requires a three-fourths (3/4) vote of the  
13          court inflicting the censure, or a three-fourths (3/4) vote of the court to  
14          which the majority of the original court delegates that authority.
