2	"Change the Boundaries of Georgia Foothills and Metro Atlanta Presbyteries"

4	Whereas Lumpkin County, GA is the farthest northern point of Metro Atlanta Presbytery;
5	and
6	
7	Whereas it lies geographically in the northeast Georgia mountains, near many churches
8	within the current boundary of Georgia Foothills Presbytery; and
9	
10	Whereas Georgia Foothills Presbytery desires to start an RUF campus ministry at University
11	of North Georgia located in the city of Dahlonega in Lumpkin County; and
12	
13	Whereas the Session of Creekstone Church, the only PCA church located in Lumpkin
14	County, is agreeable to come into Georgia Foothills Presbytery; and
15	
16	Whereas the minutes of the 46 <sup>th</sup> General Assembly established the boundary of Georgia
17	Foothills Presbytery to be the Georgia counties of Hall, Barrow, Jackson, Clarke,
18	Oconee, Habersham, and Union counties; also the counties of Oglethorpe, Elbert,
19	Madison, Hart, Franklin, Banks, White, Stephens, Rabun, and Towns; and Gwinnett
20	county north of the defined boundaries, from east to west, of Highway 316, then
21	Sugarloaf Parkway to Peachtree Industrial Boulevard, then an imaginary line
22	westward from the intersection of Peachtree Industrial Boulevard and Sugarloaf
23	Parkway to the Chattahoochee River; and
24	
25	Whereas the Minutes of the 46 <sup>th</sup> General Assembly established the boundary of Metro Atlanta
26	Presbytery to be the Georgia counties of Dekalb, Fulton, Clayton, Cobb (East of I-75),
27	Dawson, Lumpkin, Coweta, Heard, Spalding, Troup, Merriweather, Pike, Fayette,
28	Forsyth, Rockdale, Newton, Henry, and Walton; and Gwinnett county south of the defined boundaries, from east to west, of Highway 316, then Sugarloaf Parkway to
29 30	Peachtree Industrial Boulevard, then an imaginary line westward from the intersection
31	of Peachtree Industrial Boulevard, then an imaginary line westward nom the intersection of Peachtree Industrial Boulevard and Sugarloaf Parkway to the Chattahoochee River;
32	of reachine maastral boulevard and Sugariour rankway to the Chattahoochee River,
33	Therefore, be it resolved that Georgia Foothills Presbytery overtures the 52 <sup>nd</sup> General
34	Assembly as follows:
35	• That Lumpkin County be transferred from Metro Atlanta Presbytery to Georgia
36	Foothills Presbytery;
37	• By adding Lumpkin County to the list of Georgia counties included within the
38	boundary of Georgia Foothills Presbytery; and
39	• By removing Lumpkin County from the list of Georgia counties included within the
40	boundary of Metro Atlanta Presbytery.
